 Keewatin Branch Update – On Oct. 1, 2024, at a Special Meeting of City of Kenora Council, a report was provided by Greg Breen, Director of Engineering and Infrastructure, recommending a comprehensive structural assessment of the Keewatin facility. This assessment will provide data for a fulsome report that will be brought back to Council that outlines options for consideration, regarding potential next steps for the facility. The cost, up to \$50,000, will be funded through the City's Contingency Reserves. The report is expected by the end of 2024.
